Why in news: Africa Day (May 25) marks the founding of the **Organisation of African Unity** in 1963. Symbolises **unity, independence, and development** across the African continent.

AU's Digital Transformation Strategy

- The **African Union's Digital Transformation Strategy (2020–2030)** places **digital innovation** at the centre of development. Urges **governments to adopt digital solutions for socio-economic progress**.

India's Development Diplomacy Evolution

- India combines **state-led financing** with **socially embedded solutions**.
- Initiatives include **technical training, infrastructure projects, and concessional credit lines**.
- Increasing role of **social enterprises** offering **low-cost, high-impact innovations**.

India's Digital Approach

- A shift to **integrated, technology-driven partnerships**.
- Builds on **Pan-African e-Network (2009)** for **tele-medicine and tele-education** via satellite and fibre-optics.
- Based on **India's Digital Public Infrastructure (DPI)**: Aadhaar, UPI, CoWIN, DIKSHA.
- India now focuses on **sharing/co-creating digital solutions** to address **governance and service delivery**.

Africa's Digital Shift

- **African nations align with**: Policy and Regulatory Initiative for Digital Africa, Smart Africa Alliance.
- **Objective: Inclusive and sustainable development** via technology.

Emerging India–Africa Digital Collaborations

- **2021**: Togo's National Agency for Identification signed MoU with **IIIT-Bangalore** for a **Modular Open-Source ID Platform**.
- **2023**: Zambia signed MoU with **Centre for Digital Public Infrastructure (IIIT-B)** for **Smart Zambia Initiative**.
- **2024**: Bank of Namibia partnered with **NPCI** to develop **UPI-like payment system**.
- **Ghana** integrating its system with **India's UPI** for **faster transactions**.
- India's **DPI model** praised for **affordability, scalability, and public-oriented design**.

Global Context of Digital Partnerships

- African nations select digital partners based on **capacity to meet national priorities**, not ideology.
- **China** preferred in infrastructure due to **state-backed financing**. **India, EU, US** are also **key contenders**.
- **India stands out with**: Open-source, public-oriented DPI, Avoids surveillance-driven or proprietary models, Advocates state-led co-development.

IIT Madras Zanzibar Campus

- First **overseas IIT campus** launched in **Zanzibar**. Offers courses in **Data Science and AI**. Funded with help from **Indian private sector** for scholarships. Aims at **technical capacity-building** aligned with **socio-economic goals**.

Key Challenges in Africa

- **World's largest digital divide** persists.



- **Barriers include:** High costs of data/devices, Rural-urban connectivity disparities, Gender gap in digital access/literacy. **Energy supply** is a bottleneck for digital infrastructure.
- Calls for investment in **sustainable power** and **grid expansion**.

Digital Governance Progress

- 85% of African nations have **digital ID systems**. Over 70% collect **biometric data** for authentication.
- Presents a solid base for **inclusive and interoperable platforms**.

Way Forward

- **Proposed India–Africa digital compact should be anchored in:** Mutual respect, Co-development and Long-term institutional partnerships. Can serve as a **scalable model for advancing digital inclusion** across Africa.
